New CompNet Paper

[Firm heterogeneity and aggregate business services exports: micro evidence from Belgium, France, Germany and Spain](#)

(Andrea Ariu et al., ECB working paper no2097 / September 2017)

This paper uses detailed micro data on service exports at the firm-destination-service level to analyse the role of firm heterogeneity in shaping aggregate service exports in Belgium, France, Germany and Spain from 2003 to 2007.

The level and the growth of aggregate service exports are decomposed into different trade margins paying special attention to firm heterogeneity within countries. The findings include that the weak export growth of France is at least partly due to poor performance by small exporters. By contrast, small exporters in Belgium, Germany and Spain are the most dynamic contributors to their respective aggregate exports.

Start of the new data collection

The data collection for the 6th vintage of the CompNet dataset has begun. We are currently sending out the new code to the data providers, both central banks and statistical institutes, asking them to run the code on their rich firm-level database. We greatly value the contributions the data providers make to the project and we expect to get the first results back from them by the end of November. Already 16 country groups have committed to participating and we are in discussion with several others.

2nd CompNet Training course

Following the success of the *firm-level applied econometrics* course at Tinbergen last July, CompNet has organized a second training, with the assistance of IWH experts – to be held at the European Commission on 15th and 16th of November.

The course will provide an accessible treatment of state-of-the-art methods used to estimate firm's performances and allocative inefficiencies, using firm-level data. Besides discussing recent empirical work in the field, the course will focus on practical issues by offering hands-on practical sessions.

PIIE conference

CompNet pledged to sponsor an anticipated event at the Peterson Institute for International Economics (PIIE) in Washington, DC. It will take place on November 9th, on the "Impact of lower productivity". Gian-marco Ottaviano and Filippo di Mauro will present a paper on firm heterogeneity and export competitiveness.
