In the last few years, the ADBI has provided support and hosted conferences (see for instance the last on [September 2020](#)), aimed at fostering an adequate micro data infrastructure in Asia for research and policy use on productivity enhancement. The COVID-19 epidemic and the associated acceleration in the pace of digitalization and innovation, had provided further motivation for analysing granular information at the firm level. Firms are required to adapt to the new standards and procedures in order to survive.
